

Statement concerning REACH

In accordance with the Reach Regulation (EC) No 1907/2006 of the European Parliament and of the Council of 18 December 2006¹, CERSANIT II S.A. is qualified as: **a downstream user** of chemical substances and the articles we manufacture, such as bathtubs, shower bases and bathroom furniture **are not subject to pre-registration in REACH** (pursuant to Article 7 regarding the registration and notification of substances contained in articles).

Please, be informed that we are aware of the obligations of a downstream user and manufacturer of articles laid down in article 33 of the aforementioned regulation regarding the duty to communicate information on substances and preparations contained in articles and the information available to us allows safe use of the article. As a manufacturer responsible for its articles, we would like to state that there is no intended release of substances during the use of articles.

Moreover, our suppliers assure that the substances contained in our articles were pre-registered. They are also not included in the ECHA Candidate List (containing SVHC substances) annex XIV to the regulation (EC) No 1907/2006.

Therefore, we hereby state that we meet the assumptions of the REACH regulation and the requirements of the ECHA Agency.
